## About

The European Penitentiary Training Academies Network (EPTA) was founded in 2010 by heads of European Penitentiary Staff Training Academies to provide for a structure that supports sharing of training methodologies and contents across Europe.

EPTA aims at developing a cooperation that enhances initial and continuous training of correctional staff and at contributing to boost awareness of the correctional staff's work in prison and probation settings. From the 11 founding members in 2010, the network extended to 35 members from all regions of Europe today.

EPTA members meet once a year for two days to discuss the latest developments in the sector. In the periods between the meetings, members enter into bilateral sharing of information about mutual visits to facilitate direct exchanges.

## EPTA Project

On behalf of EPTA, the Netherlands Helsinki Committee applied in conjunction with EuroPris and the National Training Academies from Bulgaria, France, Ireland, and Romania, for an EU funded project 'Innovating together: Connecting European Penitentiary Training Academies'. The intention of the project is to connect European Penitentiary Training Academies and stimulate further professionalization and engagement within the network, support the organization of the upcoming three Annual Conferences and invite EPTA members to a number of international trainings. This, in turn, will allow existing and future European members to collectively benefit from the results. The project started in 2021 and will be finalized in 2024.
