#### **EPTA History**

- Meetings of Heads of European Penitentiary Staff Training Academies
- 2008 in France: Decision about European network of Penitentiary Training Academies
- 2009 in Italy: Draft of joint declaration and accession protocol
- 2010 in Spain: Signed declaration and protocol of engagement by 11 members (Andorra, Belgium, Catalonia, Croatia, France, Italy, Norway, Romania, Spain, Sweden, Switzerland) to provide a structure that supports the sharing of effective training methodologies and contents across Europe
- 2016: EuroPris signed a Memorandum of Understanding to support the network



#### **EPTA History**

- 2018: EPTA, Netherlands Helsinki Committee (NHC) and EuroPris, devised a project idea with the intention of creating a sustainable, professional and active EPTA network by stimulating participation & exchanges within the wider network → Funded by the EU
- 2018-2021: EPTA I Project "Tackling Gaps in Cross-Border Cooperation for Penitentiary Training Academies"
- 2021-2023: EPTA II Project "Innovating Together: Connecting European Penitentiary Training Academies"
- These projects have provided substantial funds to enable the growth of the Network, e.g.
   Development of the EPTA website, fully funded Annual Conferences, fully funded cross-border training events, publication of training manuals.



#### What Next for EPTA?

- Current membership stands at 36 members
- No further project
- No funding source to continue coordinated activities
- How do we continue to grow in terms of co-operation among members and of result?
- What are the options?



#### Option I - Return to Pre-Project Status

- Current structure remains, i.e. Steering Committee, Presidency etc.
- EPTA stays as an independent organisation
- EuroPris stays as the secretariat of EPTA in accordance with the Memorandum of Understanding from 2016
- Same status as before the projects, no funding
- EuroPris keeps one seat on the EPTA steering committee



#### Option I - Not an Option

- Current structure remains, i.e. Steering Committee, Presidency etc. current membership
  has outgrown the current structure not fit for purpose
- EPTA stays as an independent organisation No legal status
- EuroPris stays as the secretariat of EPTA in accordance with memorandum EuroPris discontinues support, EPTA stagnates
- Same status as before the projects no funding means no activities. Progress achieved through previous projects would be lost
- EuroPris keeps one seat on the EPTA steering committee Why?



#### No legal status - what does it mean?

- No legal person (no registration)
- No bank account to collect membership or registration fees
- No point of contact
- No employer status
- No staff resources dedicated to EPTA



## EuroPris discontinues support – what does it mean?

- No secretariat lack of communication amongst members
- No contact point
- No website
- No support for the EPTA President
